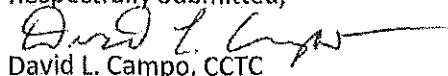

To the members of the Waterford RTM:

I respectfully ask that you reconsider your approval for the building of a Data Center on the property of Dominion in Waterford. There are several reasons for my concerns:

1. As an immediate neighbor with property abutting the site, I have concerns about the noise that will emanate from the building. Please seek the input of medical professionals in their specific fields to know how even a slight humming can affect individuals, causing hearing loss, stress, and other health issues. Get some good, knowledgeable input from them as well as professional noise meter readings from unrelated firms.
2. Wildlife/Environmental: over 50 acres will be destroyed; some treed, some not. However, we have an abundance of wildlife that live there that we see every day. It would be a shame to devastate their natural habitat. We have birds, deer, turkey, rabbits and yes, even bobcats, that live nearby. I have concerns regarding their fate. I also care about the loss of trees which help with carbon dioxide removal and the loss of oxygen potential. This is NOT a good thing for the environment or for Waterford.
3. Another consideration, and also for even more distant residents, is the larger terrorist threat to this location. During 9/11, everyone was concerned about an attack on the power plant. Besides ground security, we even had the US Coast Guard out on the Bay. Sadly, putting a huge data center is only going to give terrorists a bigger target, with a GREAT Big X on it that will have a far-reaching effect. Please use common sense.
4. I understand the Unions want contracting jobs, however, many of these workers will be brought in and many will not be from our immediate area. These jobs will only last two years as well, but will leave the residents to live with this in the area for most of their lives. This is not fair to local residents.
5. The so-called POSSIBLE tax dollars return to the town of Waterford, which are not guaranteed, will not make up for the loss of property values and quality of life.

Please reconsider your support for this project and consider the concerns of local residents.

Dear Ladies and Gentlemen of the Waterford Representative Town Meeting:

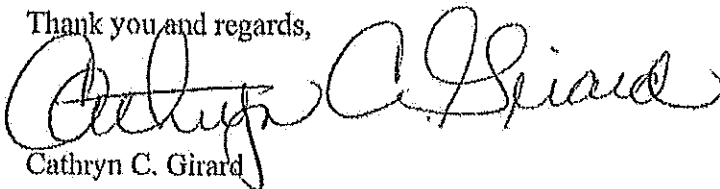
I wish to call your attention to the previously provided packet of information from me concerning the above referenced topic and the VISION ZERO project recently enacted into law by the CT Legislature.

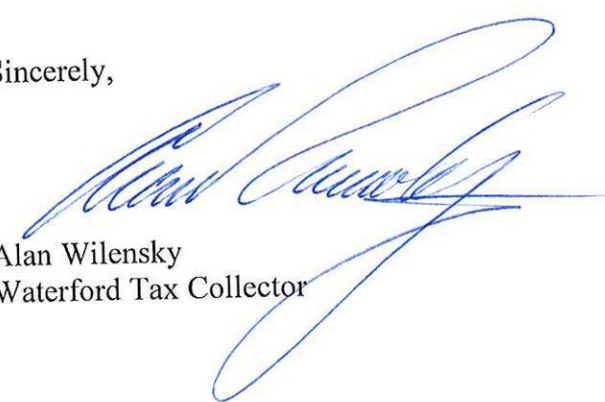

Re: Vision Zero Traffic Camera Enforcement Program

The Waterford Board of Police Commissioners met at their regularly scheduled meeting on Monday, March 11, 2024, and discussed the Vision Zero Traffic Safety Enforcement Program. The Board of Police Commissioners, who would be the first board to approve the program for the town as the Local Traffic Authority, agreed with my recommendation to not take action at this time. Should the Board of Police Commissioners agree to allow the use of camera enforcement in Waterford, other boards and commissions would then need to be involved to meet all state requirements, such as creating an ordinance, entering into agreements with vendors and expenditure of funds.

As many boards may have received correspondence from a resident in town over this fairly new authority approved by the state, there are many requirements and our department has been and will continue to research all aspects of the authority to present to the Board of Police Commissioners when appropriate.

As of my meeting with state officials last week over this program, not one application has been submitted in the State of Connecticut to the Office of State Traffic Administration.

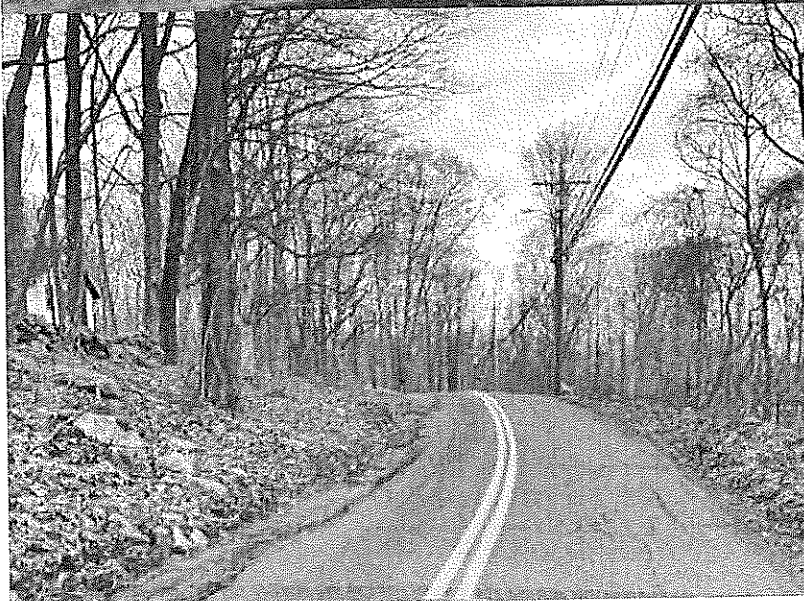
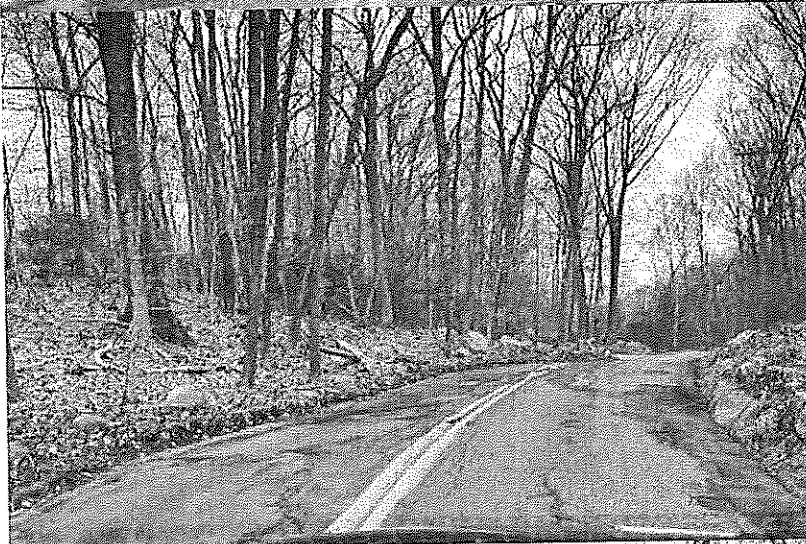
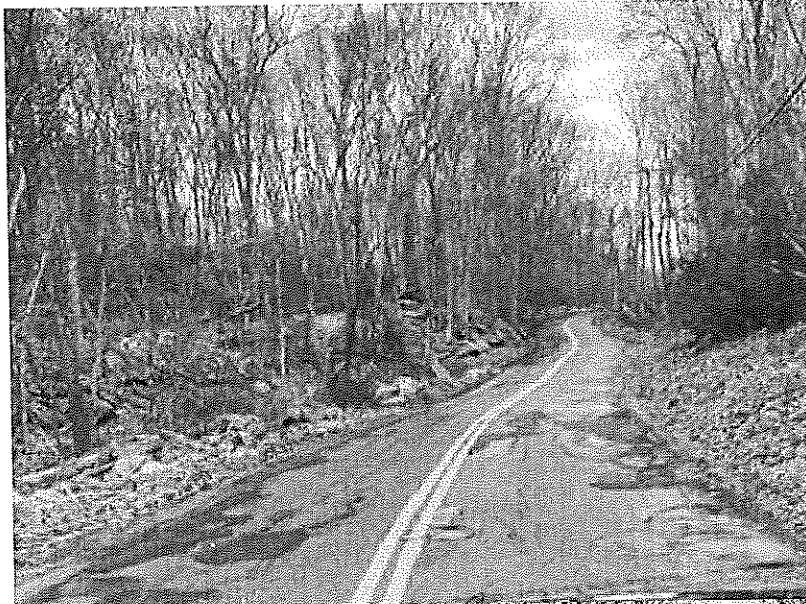
I am writing this letter to address the state of Vauxhall St Extension from Hunts Brook Road to the Montville Town Line. This section of roadway has not had any significant repair, paving or resurfacing since the early 2000's. I moved into my residence back in 2003 and remember not too long after that date that the road was oiled and graveled around, I believe sometime around 2006. Since that time, the portion of Vauxhall St Ext between Twin Lakes and Hunts Brook has been fully repaved and updated, and twice in the area around Twin Lakes. It is imperative that this northern section of roadway be immediately evaluated for safety reasons. I have been monitoring the degradation of this roadway over the past couple of years and have documented the deprivation in the photos below. The poor health of this roadway and its narrow areas make it truly one of the towns most unsafe areas to drive, especially with large & wide vehicle usage and most importantly the horrible drainage issues that seem to be getting worst by the month. At this point we have more than 50% of the entire width of the road, the entire southbound lane, submerged under water every single rainstorm. I realize this section of town has some areas of ledge and would require engineering to jack hammer, elevate or blast to widen the road, but the work needs to be executed to deal with the simple fact that this is a primary detour for route RT 85 in emergency situations. In the near term, dealing with the drainage and resurfacing is a simple task and one that can be completed this year to manage the unsafe and unsatisfactory condition of the roadway. The approach to managing the main section of roadway submerged, in the area of 970 Vauxhall St Ext, could be resolved much like the town did on Gardiners Wood roadway, by elevating the affected section with under roadway culverts.

I will leave the engineering work to the town, but request that the First Selectman, the Director of Public Works and the RTM review the capitol paving list of 2024 and evaluate the opportunity to resolve this very unsafe, deteriorated and neglected roadway for immediate improvements so that residence can drive safely each and every day.

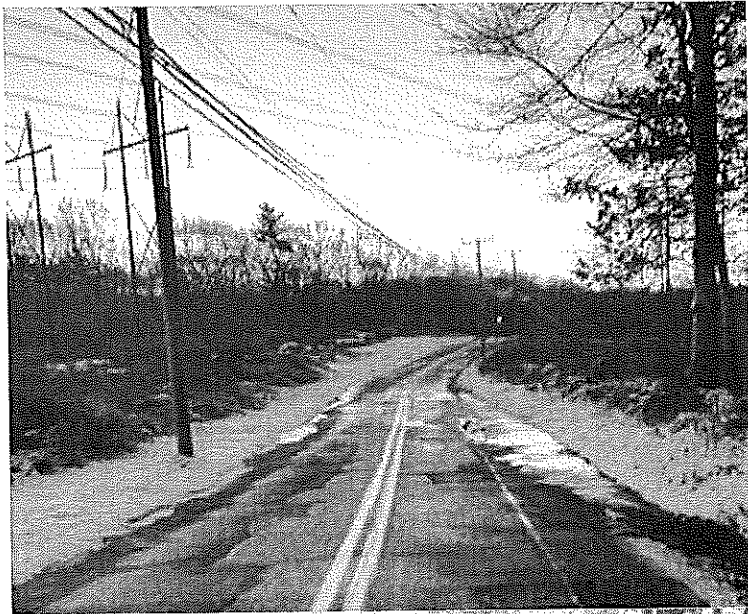


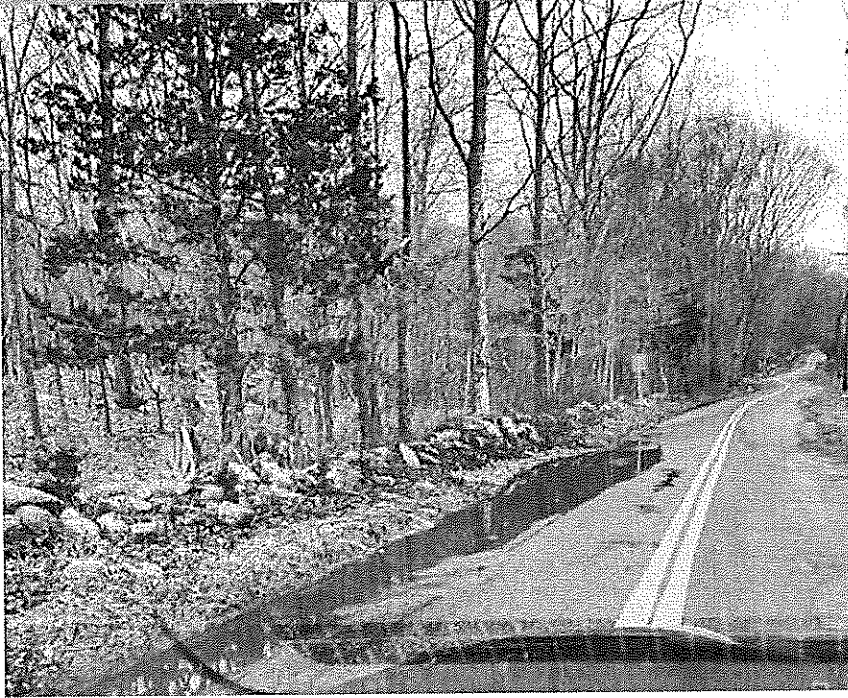
Drainage Degradation – Rain & Ice (2018 - 2024)

Enclosed is the Town's staffing roster for General Government as of December 31, 2023 for the Board of Finance and the Representative Town Meeting (RTM). Included in the packet are three (3) documents: the 5-year Staff Summary, the Staff Summary as of December 31, 2023 and the Staffing Roster as of December 31, 2023.

Significant changes since December 2022 include:

Board of Selectmen: The First Selectman's office *added* a substitute Executive Assistant to provide coverage when the full-time Executive Assistant is out of the office.

Assessor's Office: The part-time Assessor Aide I position was *eliminated*.

Finance Department: The Office Coordinator I position was vacated and *replaced* with the original Administrative Assistant I position. The Finance Technician position was *reclassified* and *retitled* Finance Coordinator.

Human Resources: The Administrative Assistant position was *replaced* with the Human Resources Assistant position.

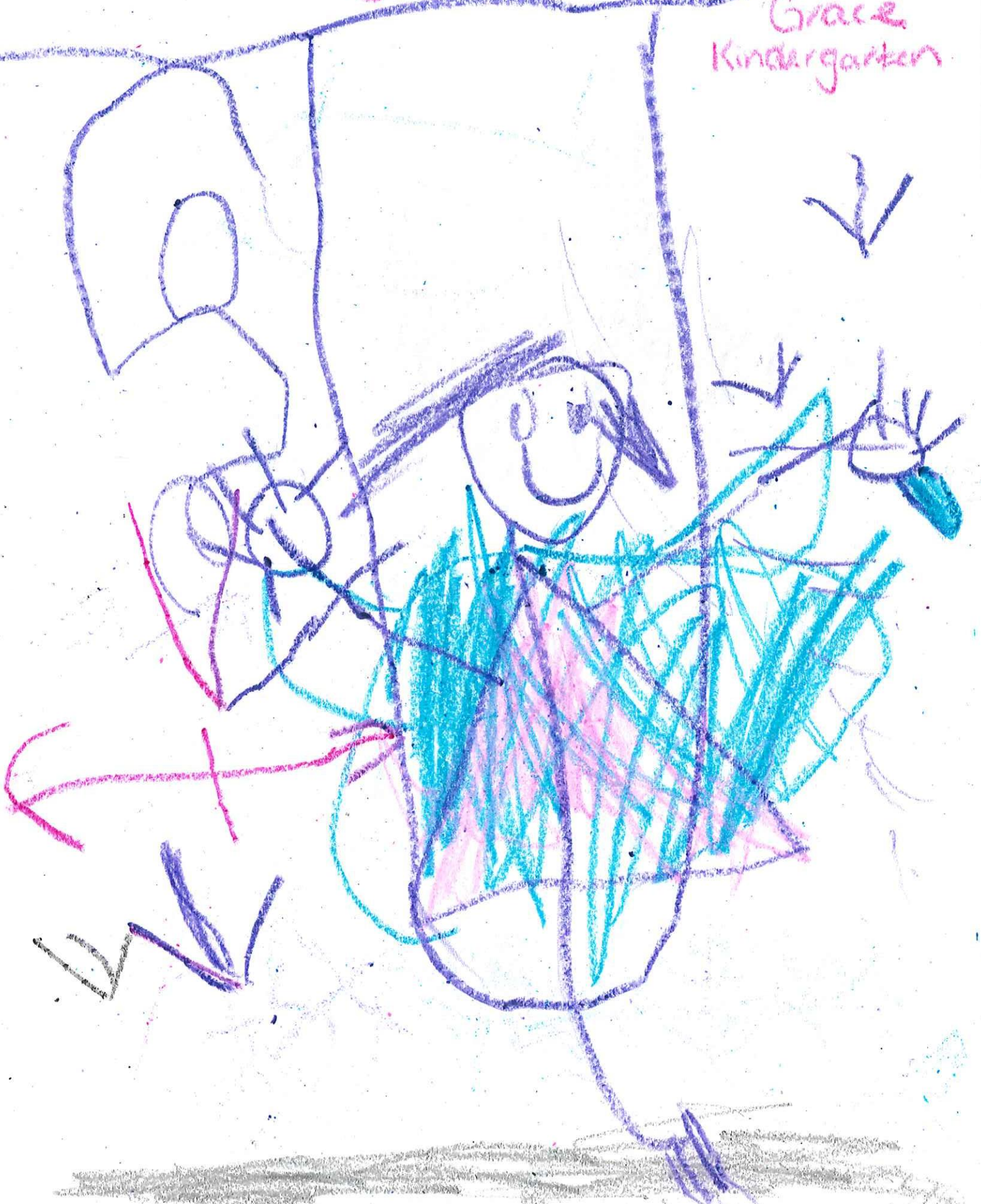

We are a family with two young girls, Ada (5) and Gwen (2). Like many families, we ask the familiar "how was your day?" with follow-up specifics like "what was your favorite part?". We enjoy bonding with Ada, who is in kindergarten, by understanding what the days of her first year in elementary school look like.

Unfortunately, Ada has expressed frustration and disappointment with not being able to use the playground as it is intended; due to water and ice collection. She has mentioned "I wish I could play on the playground but today I couldn't". The first couple of times we heard her say this we didn't think much of it, but we are noticing it is becoming a pattern and one that we feel requires a permanent resolution.

Our family walks Ada to school most days and drops her off the others. I noticed as I parked in the side-lot to walk her to the building, many areas of the sidewalk and entry to the parking area pooled with more than a few inches of water. I made it a point to identify how long it would take to drain, and so far it has been 4 days with no relief.

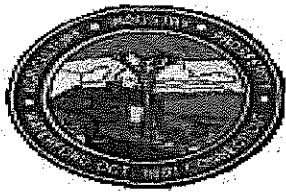

On February 27th, 2024, the Oswegatchie Fire Station Building Committee held a Special Meeting to hear presentations from and interview three candidate Program Managers who will work for the Committee as the owner's representative to coordinate and supervise the building of the new fire station and to provide construction advice to the design process, being led by the architect selected by the Town, Silver Petrucelli, and Associates (SPA). The three candidate firms, Construction Solutions Group, LLC, Downes Construction Company, and Colliers Project Leaders, were down-selected from five proposals submitted to the town and reviewed and evaluated at the Feb. 6th Building Committee meeting. At the February 27th Special Meeting, the Committee voted to select Downes Construction Company. A summary of the five bidders' proposals is attached for your review prepared by the Committee's procurement consultant, retired Fairfield Connecticut purchasing agent Twig Holland.

The Committee is requesting an appropriation of \$306,650, based upon estimates provided and tallied in the attached proposal summary.

Downes Construction Company anticipates commencing its work early April, coincident with the start of the SPA's design work and will collaborate with the committee in providing construction relevant information to SPA to complement the design the new building during 2024. As the process transitions from design to construction, the Program Manager will review adequacy and accuracy of construction drawings, develop bid paperwork for the construction of the building, and assist in selection of the construction firm. During the construction of the building, Downes Construction Company will maintain day to day oversight of all construction activities, provide weekly or more frequent reporting to the committee, manage budgets and change orders, provide construction performance metrics, and assure that the building is constructed in accordance with local codes, completed on time, and functions as intended. The goal will be to commence construction in the spring of 2025 and SPA's early target completion date is the spring of 2026.

On behalf of the residents and property owners who will benefit from this critical public safety and property protection initiative, the Committee appreciates careful consideration of this request by the Selectmen, Board of Finance and RTM members. We would be pleased to provide any additional information you might require.

We have recently had a conversation with town Attorney Kepple who advised that our first letter in which we requested \$35 per hour was in fact a request for a raise and would have required us to go before the RTM. We have amended our letter as this was not our intention.

The Registrar of Voters respectfully request your consideration for payment at our current rate for extra hours worked during primaries and elections due to the implementation of Early Voting.

The following total hours do not include prior hours worked for Early Voting training calls/emails with the Secretary of State, training Moderators and numerous IT issues.

Presidential Preference Primary

4 days (this year, March 26, 27, 28, 30, 10am – 6pm, total of 32 hours).

Other Primaries

7 days (this year, August 5,7,9,10,11, 10am -6pm, August 6, 8, 8am-8pm, total of 64 hours).

General Election

14 days (this year, October 21,22,23,24,25,26,27,28,30, Nov.1,2,3, 10a-6pm, October 29,31, 8am-8pm, total of 120 hours).

The yearly ROV salary FY2024 is \$26,912.16. Weekly salary: \$517.54. Hourly salary: \$34.50.

The yearly ROV salary for FY2025 will be \$27,248.52. Weekly salary: \$524. Hourly salary: \$34.93.

This year the Registrar's office has received a potentially one-time grant from the Secretary of the State's office, in the amount of, \$10,500, that is intended to cover staffing for Early Voting. We respectfully request \$34.50 per extra hour worked outside of our regular daily hours already covered that will come from this state grant.

Moving forward, the grant will very quickly run out and we seek guidance on compensation for the future with these additional hours.

Dear Registrars of Voters,

We have received inquiries regarding the appropriate uses of the funds from the Early Voting Grants that were issued to your towns pursuant to Public Act 23-204, including whether these funds may be applied toward pay for registrars for extra hours spent preparing for or administering early voting.

The grant agreement you submitted provides details on the intended use of the funds. Examples of acceptable utilization include such things as:

- Labor costs associated with preparing for and administering early voting, including pay for registrars working extra hours due to early voting
- Printing costs for early voting supplies
- Early Voting location related expenses
- Voter education and outreach regarding early voting
- Equipment or supplies to facilitate early voting
- Any other use directly tied to changes necessary to implement early voting

Please note that this is not an exhaustive list of acceptable uses of the grant funds. Please also remember that you must report how you use the money to the Office of the Secretary of State. Reports must include backup information such as a ledger report from your financial system or copies of purchase orders and invoices. This report is due by **January 31, 2025**.

The funds must be fully expended by December 31, 2024. If they are not fully utilized before December 31, 2024, contact the Office of the Connecticut Secretary of the State at mss@ct.gov to request an extension on utilization.

By accepting funds, the town agrees that it will comply with applicable public auditing requirements, in accordance with the provisions of Sections 7-394a and 7-396a of the Connecticut General Statutes and that the town is compliant with all applicable state and federal nondiscrimination laws.

We hope this information assists you in utilizing the grant funds to implement early voting in your town.

Early Voting in Detail

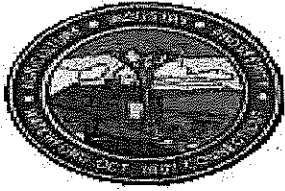
The most important thing to understand, that is often misunderstood, is that with the advent of early voting, the job of the registrar is changing significantly. For towns with only part-time election professionals, the number of hours is greatly increasing. Early voting bears no resemblance to what we are used to with Election Day voting. Not only will registrars require new training in early voting procedures, CVRS for the April election, and a new CVRS system, they must also create a plan for SOTS approval. A much higher mastery of knowledge and know-how (including database work) is required for much of the early voting staff. Even veteran poll workers will need additional training.

In addition, despite robust advocacy by our office for state funding to help offset municipal costs, the issue is undecided by the legislature.

Every town WAS granted \$10,500 for the current fiscal year, which must be applied towards the implementation of early voting. Those checks will be sent in late January and municipalities should take guidance from their Registrars on how to spend that money. **Our office has to approve all early voting plans so this will ensure that your town is in compliance.**

We encourage all leaders to reach out to their state legislative delegations to request a mid-year budget adjustment to receive funding for the next fiscal year.
