Re: **Approval of Wetland Restoration Plan, 47 Great Neck Road, Waterford, CT**
Unauthorized Clearing Within & Adjacent to Inland Wetlands & Watercourses

Mr. Taylor,

At their April 13, 2023 meeting, the Waterford Conservation Commission approved with conditions the wetland restoration plan submitted to this office on April 12, 2023.

Conditions:

1. The removal of fill and debris from a 50 ft. wide buffer area surrounding the impacted wetland depicted on the restoration plan (attached) is to be completed no later than May 30, 2023. Upland soil areas are to be seeded to establish vegetation. No fill is authorized in the wetland.
2. The wetland boundary is to be marked by boulders as indicated on the restoration plan.
3. The non-encroachment boundary established per inland wetland permit #10-03 is required to be marked by installation of 4 x 4 inch posts with identification markers at 30 ft. intervals. The non-encroachment boundary markers are provided by the Commission.
4. No later than June 1, 2023, you are required to notify the Environmental Planner to conduct an inspection of the restored area for compliance with the approved restoration plan.

STABILIZATION NOTES:

- 1) PLACE TOPSOIL APPLY LIMESTONE AND ORGANIC FERTILIZER WITH SLOW RELEASE NITROGEN AND CONTAINS NO PHOSPHOROUS. DO NOT OVER APPLY FERTILIZER.
- 2) APPLY GRASS SEED TO MANUFACTURERS RECOMMENDATIONS.
- 3) APPLY STRAW OR HAY MULCH AT ALL NEWLY SEEDED AREAS
- 4) SEED BETWEEN APRIL 1ST AND JUNE 15TH
