DEAR MR. BERNARDO,

AT YOUR REQUEST I HAVE DELINEATED THE INLAND WETLANDS AND WATERCOURSE ON THE ABOVE REFERENCED PROPERTIES.

THESE WETLANDS HAVE BEEN DELINEATED IN ACCORDANCE WITH THE STANDARDS OF THE NATIONAL COOPERATIVE SOIL SURVEY AND THE DEFINITIONS OF WETLANDS AND WATERCOURSES AS FOUND IN THE CONNECTICUT STATUTES, CHAPTER 440, SECTION 22A-38.

FLUORESCENT PINK FLAGS WITH A CORRESPONDING LOCATION NUMBER DELINEATE THE BOUNDARY OF THE INLAND WETLANDS/WATERCOURSE.

FLAG SERIES WF- 1 THROUGH WF-150 DELINEATE THE NORTHERN AND EASTERN BOUNDARIES OF A LARGE PALUSTRINE FORESTED WETLAND FOUND IN THE WESTERN PORTION OF THE PARCEL. ON THE DATE OF THE DELINEATION, (1/4/2022), THE MAJORITY OF THIS WETLAND WAS INUNDATED.

A WATERCOURSE FLOWS ONTO THE PROPERTY UNDER THE POWER LINE ACCESS ROAD ALONG THE NORTHERN BOUNDARY, AND FLOWS TO THE SOUTH INTO THE NORTHERN PORTION OF THE WETLAND.

THESE WETLAND SOILS ARE CHARACTERIZED BY SHALLOW REDOXIMORPHIC FEATURES AND LOW CHROMA COLORS WITHIN 20 INCHES OF THE SOIL SURFACE.
