Please see Attachment 2 combined, the monthly running of WAM, WAY, and Annualized ALPHA to get a more accurate picture of our portfolio.

As you observe our ALPHA, which measures performance, I underperformed our benchmark in Jan, Feb and Mar by (-.18%, -.23% and -.15%, respectively). Our Weighted Average Yield (WAY) is 3.56% in Mar of 2026.

Attachments 3 & 4 show our interest income with comparable amounts from previous years. **FY 2026 3rd quarter of \$2,375,349 vs FY 2025 3rd quarter of \$3,092,248.** Two reasons for the reduced interest;

1. Nearly 10 million less in over all funds, please see bottom of the page on attachment 1
2. Interest rates are down by approximate .75% since last fiscal year.

...quick note on Oswegatchie building fund: We received \$13,846,779.85 on 3/10/2026 which was deposited at STIF. You'll see the updated Bond debt service in my July report.
