The Board of Selectmen to consider and act on the following budgets and at the appropriate time forward to the Board of Finance for their consideration of and action on the FY 20/21 Budgets for:

a. Public Works

MOTION was made by Ms. Nazarchyk and seconded by Ms. Sabilia to tentatively approve the Public Works budget request for FY20/21 in the total amount of \$4,689,207. **VOTE: 3-0.**

b. Fire Services

MOTION was made by Ms. Nazarchyk and seconded by Ms. Sabilia to tentatively approve the Fire Services budget request for FY20/21 in the total amount of \$3,102,392. **VOTE: 3-0.**

c. Recreation and Parks

MOTION was made by Ms. Nazarchyk and seconded by Ms. Sabilia to tentatively approve the Recreation and Parks budget request for FY20/21 in the total amount of \$1,519,608. **VOTE 3-0**

d. Community Use of Schools

MOTION was made by Ms. Nazarchyk and seconded by Ms. Sabilia to tentatively approve the Community Use of Schools budget request for FY20/21 in the total amount of \$86,126. **VOTE 3-0**

e. Finance Department

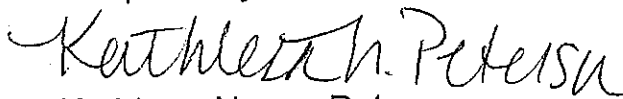
