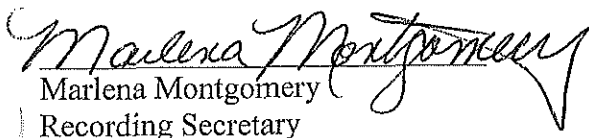
NEW BUSINESS
